SUBJECT:	Approval to Replace End of Life Firewalls and Extend Service on Current Equipment

#### **RECOMMENDED ACTION:**

- 1. Amend the list of Technology Plan Projects to include replacing Firewalls as a Year Two project.
- 2. Approve the purchase of 7 firewalls with 3 years of FortiCare and FortiGuard Unified Threat Protection at a cost of \$187,763.63, with expenditures being paid from the Technology Plan Budget.
- 3. Approve purchasing 3 years of FortiCare and FortiGuard on Fresno, Kern, and the monitoring equipment in the data center so all firewalls are on the subscription term at a cost of \$52,336.48, with expenditures being paid from the Technology Plan Budget.
- 4. Approve extending service on Mariposa's existing firewall through the End of Service date, 7/15/26, at a cost of \$13,407.63, with expenditures being paid from the Technology Plan Budget.

Approval of the recommended action will amend the list of Technology Plan Projects to include Firewall replacements with expenditures being paid from the Technology Plan budget for a total of \$253,507.74.

## ALTERNATIVE ACTION(S):

Alternatively, Administrative Council could elect to replace the firewalls and only pay for a single year of FortiCare and FortiGuard at a cost of \$106,235.93 and a single year of service on existing equipment at a cost of \$27,229.82 Or, if we do not replace the firewalls, we will have to shut off internet access, because we will be unable to filter internet traffic, as required by E-Rate.

## FISCAL IMPACT:

Approval of the recommended action will not have an impact on membership dues and will authorize a maximum expenditure of \$255,000 from SJVLS's Technology Plan budget for the replacement of the end-of-life firewalls, depending on the length of service selected.

## **DISCUSSION:**

The FortiNet 600D firewalls located at 7 member headquarter locations are going end-of-life in September and need to be replaced in order to continue protecting the network. These locations currently have 600Ds as their firewalls:

- Coalinga-Huron
- Kings County
- Madera County
- Merced County
- Porterville City
- Tulare County

• Tulare Public (City)

After speaking with FortiNet staff, SJVLS staff were informed that FortiNet will not renew services on devices that will go end of life during the subscription term. Our current renewal date for FortiCare and FortiGuard is August 7<sup>th</sup>. SJVLS is requesting approval to replace the end-of-life firewalls in advance of the renewal and to extend services on current equipment for 3 years, so that all of our firewalls are current, co-termed, and we only have to pay a single renewal invoice for all members at once.

The current 601E firewalls in use at Kern and Fresno County headquarters, as well as the virtual machine monitoring the data center, do not have a current end-of-service date, and can be extended and co-termed with the new firewalls, providing service through 8/6/2027, at a cost of \$52,336.48.

The current 501-E firewall at Mariposa County has an end-of-service date of 7/15/2026. Coverage can only be extended through that date for their equipment, at a cost of \$13,407.63. The firewall will need to be replaced prior to the end-of-service date.
